GENERAL CONDITIONS

(Also appearing on reverse side of guarantee)

1. WATER LEAKAGE. Structural or mechanical defects which may result in water leakage on treated areas, including leakage in interior areas or through the roof or exterior walls of the identified property, may destroy the effectiveness of treatment. Such leakage can further produce unusual situations abnormally conducive to new infestation. If such conditions are discovered, it is agreed that the purchaser will be responsible for making such repairs as are necessary to correct said defects and for repairing any damage which was caused by said water leakage and/or termite infestation allowed to continue as a consequence of such leakage. Sovereign Pest Control will, upon completion of repairs necessary to correct said defects, provide additional treatment to control infestation in the area. The cost of said additional treatment will be paid by the purchaser.

2. ENTIRE AGREEMENT. The guarantee constitutes the entire agreement between the parties and no other representation or statements will be binding upon parties.

3. NOTICE OF CLAIMS, ACCESS TO PROPERTY. Any claim for breach of this agreement will be made immediately in writing to any Sovereign Pest Control office. Sovereign Pest Control is only obligated to perform under this agreement provided the Purchaser allows Sovereign Pest Control access to identified property for any purpose contemplated by this agreement, including but not limited to reinspection, whether the inspection was requested by the Purchaser or considered necessary by Sovereign Pest Control.

4. DISCLAIMER.

A. Sovereign Pest Control's liability under this agreement will be terminated if Sovereign Pest Control is prevented from fulfilling responsibilities under this agreement by reasons of delays in transportation, shortages or fuel and/or materials, strikes, embargoes, fires, floods, quarantine restrictions or any other act of God or circumstances of cause beyond the control of Sovereign Pest Control.

B. Sovereign Pest Control disclaims any liability for special, incidental or consequential damages. The guarantees stated in this agreement are given in lieu of any other guarantee or warranties, express or implied, including any warranty or merchantability or fitness for a particular purpose.

C. Sovereign Pest Control makes no representation as to ever having previously treated this property.

D. Any termite infestation and any damage from such infestation discovered after the contract has been cancelled is not the responsibility of Sovereign Pest Control.

E. Formosan Termites are excluded from any coverage provided in this contract.

5. NON-PAYMENT. In the case of non-payment by the Purchaser, reasonable attorney fees and cost of collection shall be paid by the Purchaser, whether suit is filed or not.

6. NO AFFILIATION. The Corporate party with whom the Purchaser has contracted is set forth opposite the Purchaser's signature on the reverse hereof. Purchaser acknowledges that such Corporate party is a corporation which is separate and distinct from any other entity who or which may perform or provide similar services and trade under the name Sovereign Pest Control or a similar name.

7. If the initial plan period on the front of the contract is not clearly selected, the initial service plan period will automatically default to one year.

8. Any provision for a limitation of liability based upon any modification or addition to the structure as depicted in the diagram attached to this contract shall be set forth in the Contract so that the homeowner understands that he is responsible for notifying Sovereign Pest Control of any modifications or alterations which are made during any contract period.

9. The removal of the bait or baiting system may result in a lack of termite protection. Sovereign has the right to charge \$25 for any stations that go missing or are damaged during the contract term.
